

# STMA in Action

Early on the morning of May 9, a crowd of approximately 50 gathered at the Appleton Nienhaus Sports Complex. The attraction was the Wisconsin Sports Turf Managers Association Spring Chapter Meeting. Conversation flowed as early arrivers sipped coffee and munched donuts near the registration area.

President Rich Riggs, R. H. Rettler Corporation, officially opened the meeting at 8 a.m. with a welcome and an overview of the day's events. Dr. John Stier, University of Wisconsin, a strong supporter of STMA and the chapter, was next on the program. Steve Trusty, STMA executive director, provided an update on the association and its services for members and chapters. He also gave an overview of the Certified Sports Field Manager program, including the process of preparing the supporting materials to qualify to take the exam. Both speakers allowed time for a question and answer session at the end of their presentation.

The group moved to the field for the demonstration portion of the program. Bill Findlay, head groundskeeper for

the St. Louis Cardinals, shared his expertise in infield maintenance, including showing and discussing techniques for the pitchers mound maintenance. Dave Cygan of Pro's Choice (a Gold Level Chapter Sponsor) also demonstrated and discussed infield maintenance techniques, including methods of drying a wet field to allow play. These up-close demonstration sessions allowed an easy exchange of questions and answers between the attendees and demonstrators. This is always a plus in such areas as infield maintenance where the science of sports turf management blends with the art of grooming varying clay-sand-amendment mixtures to the precise conditions to best support play.

Following the demonstrations, the group traveled to the Wisconsin Timber Rattlers Stadium for lunch. Rich Riggs and Jesse Mulman, groundskeepers for the Timber Rattlers, addressed attendees during this segment of the meeting. The group then observed as Mulman and the Timber Rattlers grounds crew worked through their standard pre-game field preparation.
