



This is the problem with football teams having large animals as mascots, the fact that they need to relieve themselves from time to time on your turf. Typically

the area where the horse makes his mark is on the non painted areas leaving a brown spot in the days following the game. These brown spots are either plugged out or allowed to re-grow if adequate time is allowed between games. On this occasion, Renegade the horse chose a painted area to get some relief. At least it wasn't a pile of horse chips or that may have given a whole new meaning to goal line stance!
