- Nominating: To provide to the membership a qualified slate of officers and directors for the annual STMA Board of Directors election in accordance with the STMA Bylaws.
- Past President's Advisory Council: Purpose: To advise the STMA Board on issues pertaining to the past, present and future of STMA. (Restricted to STMA Past Presidents)
- Scholarship: To judge the SAFE Scholarship recipients; to develop strategies to enhance the program.
- Technical Standards: To help determine standards and best management practices needed in the profession and to guide the work of the ASTM on developing sports field and facility standards.
- Website: To insure that the STMA website contains information relevant to members, prospects and the green industry in an easily accessible and consumable format.

STMA awards 2008 Fields of the Year

The STMA Awards Committee has honored 10 members with Field of the Year Awards. The winners will be recognized at the annual STMA Awards Banquet January 16 in San José. In addition to being presented with a prestigious plaque, each winner also receives a complimentary conference registration, additional banquet tickets, signature clothing, three nights hotel while in San José, and recognition in an issue of this magazine.

Criteria is based on the management techniques of the sports turf manager, innovative solutions to problems, the ability to maximize budget dollars and resources, and the safety and playability of the field's surface. A new category was introduced this year, Sporting Grounds of the Year. Members entered natural sports surfaces used for less traditional sports.
